# 精益求精 穩健發展

107年對於全球金融市場是詭譎多變的一年,自美國公布對中國貿易高達500億美元商品徵收額外關稅,為美中及全球貿易戰揭開序幕,不管是股匯債市或商品原物料均受波及;惟臺灣期貨市場憑藉著推出新商品與交易制度的調整,挹注了市場動能並使交易更趨活絡,在國際金融市場波動趨大及交易人逐漸熟悉運用夜盤避險等因素推升下,交易量超過3億808萬口,為臺灣期貨市場年度交易量首次突破3億口大關。

107年也是期貨業精益求精的一年,為強化期貨商的風險控管機制及解析代為沖銷與善良管理人義務之性質與內涵,本公會委外進行代為沖銷相關研究案;為瞭解國際市場的造市功能與制度,以及流動性風險對造市功能之影響,委外辦理造市制度功能之研究;為健全期貨交易及保護交易人,委外研究分析違法經營期貨業務罪名之行為態樣。

在主管機關大力支持及期貨同業積極爭取下,財政部業於107年底取消股價類期貨交易稅率減半落日條款,自108年1月1日起實施,為期貨市場提供良好發展環境;為讓證券期貨業證照管理具一致性,建議取消期貨業業務員5年未登記喪失資格之規定,主管機關也已於108年2月預告修正相關管理規則;為擴大期貨新藍海-槓桿交易商市場規模,並提供交易人多元化資產配置選擇,本公會積極爭取增加槓桿交易商的通路及提供服務對象,建議開放「期貨商及期貨交易輔助人受託買賣業務員得轉介各類槓桿保證金契約」,以及「建議槓桿交易商對屬自然人之一般客戶得提供除外幣保證金外之差價合約(CFD)商品交易服務」,以及「建議華僑及外國人得從事之期貨交易之範圍增加槓桿保證金契約交易」等。

鑒於全球氣候變遷加劇,國內823水患造成中南部鉅額農損,美東9月中旬遭受強烈颶風侵襲,重創棉花、玉米、黃豆產量,加上中美貿易戰,種種突發的天災或人為因素,導致農糧價格劇幅波動,本公會之「臺北國際期貨論壇」,分別以糧食供需分析、農產品避險工具及農產保險發展概況等主題,邀請專家深入探討以分享經驗,另一方面協辦LME交易暨倉儲訓練課程,以實踐期貨服務實體經濟之功能。期許未來,持續連結全球,強化國際競爭力,以服務實體經濟並吸引全球資金,將臺灣期貨市場帶入嶄新的境界。

Message from CNFA Chairman Preface

#### **Contineously Striving for Improvement and Development**

2018 was a year of turbulent change for the global financial market. Since the United States announced the imposition of up to US\$50 billion in additional tariffs on Chinese trade, which kicked off US-China and global trade wars. No matter it's the market of securities, foreign exchange, commodities, or raw materials, all were impacted by this. Only Taiwan's futures market, where new commodities and adjustments to the trading system were just introduced, injected market kinetics and made transactions more laissez-faire. While the international financial market became increasing volate and traders turned progressively more familiar with the use of night trading and other such factors, the annual futures transaction volume exceeded 308.08 million lots in 2018, passing the 300 million mark for the first time in the Taiwan futures market.

2018 was also a year of constantly striving for perfection in the futures industry. In order to reinforce risk control mechanisms for futures dealers and to analyze the nature and implication of obligations on dealers who make sett-off on behalf of clients, the Chinese National Futures Association (CNFA) outsourced the execution of relevant research cases on this issue. To understand the market-making functions and system of international markets, as well as the impact of liquidity risks on market-making functionality, we outsourced studies carried out on market-making system functionality. In the interests of sound futures trading and for the protection of traders, we outsourced research and analysis of criminal behavior in illegal operations in the futures business.

With the vigorous support of the competent authorities and the enthusiastic efforts of the futures industry, the Ministry of Finance at the end of 2018 annouced the reduction in stock price futures trading tax rate by half, which took effect on January 1, 2019, providing an excellent development environment for the futures market.

To allow consistency in licenses management of futures and securities industries, the CNFA once suggested cancellation of this regulation that a futures sales person would become disqualified if he or she has not registered with the CNFA for five years. The competent authority announced in February, 2019 that it agreed with the CNFA and would announce relevant management rules later. In order to expand the blue-sea market of the futures industry—especially regarding the niche of margins trading and to provide traders with diversified asset allocation options, the CNFA actively strives to increase channels for margins traders and provides diverse targets for service. We put forward proposals that "futures dealers and futures IB workers, who are commissioned by clients to make futures trading, would be allowed to refer margin-trading or related government-approved products to their clients, " "margin dealers would be allowed to provide trading services apart from CFD commodity contracts to individual clients" and "leverage margin trading should be added to the range of futures-related trading activities opened to overseas Chinese and foreigners."

Considering the drastic fluctuations in the price of agricultural products due to the intensification of global climate change, as well as the huge agricultural losses caused by the 823 flooding disaster in central and southern Taiwan, the powerful hurricanes that made landfall on the US east coast in mid-September, hitting the production of cotton, corn and soybeans, and the Shina-US trade war, and various kinds of sudden natural or man-made disasters, the NCFA held the "Taipei International Futures Forum," inviting experts to discuss in depth, and share experiences on the themes of analysis of food supply and demand, agricultural product hedging tools and development of agricultural insurance. We also co-organized LME trade and warehousing training courses to enable practice of the functions of futures services in the physical economy. We hope that in the future we will be able to continue to link the world and improve international competitiveness to serve the physical economy and attract global capital, taking Taiwan futures market to a new level.

- 本公會前身為創立於民國84年4月17日之「台北市期貨商業同業公會」,為配合期貨產業之開放,因應業種、會員業務類別之增加,以及分布區域之擴大,遂於93年6月21日升格改制為全國性單一公會,並於6月30日獲頒立案證書。
- 本公會目前之組織型態為全國性之自律機構,除辦理會員證照登錄、場地設備勘查、從業人員教育訓練等服務功能外;更擔負了主管機關所賦予之自律職責。為促使國內期貨市場健全發展,本公會將確實完成從業人員資格審查、場地檢查、會員查核、教育訓練等四大自律職能與機制;並積極協調業界團結合作,促進業界與主管機關之溝通與互動,在熱忱、積極、完美的品質政策下,期能為期貨業之發展奠定更穩健之基石。

# **CNFA** Introduction

# A. CNFA History

- The Chinese National Futures Association (hereinafter referred to the Association or CNFA) was transformed from its predecessor, the Taipei Futures Association first founded on April 17, 1995, as a national organization on June 21, 2004 and obtained the certificate issued by the Ministry of the Interior on June 30 of the same year, a move in reflection of the market liberalization, business diversification, as well as expansion in the Association's membership and covered geographical area.
- As a national self-disciplined organization, the Association handled members' license registrations, site equipment inspections, personnel training and other functions. Moreover, it assumes the responsibility as a self-regulatory body. For healthy development of Taiwan's futures market, the Association develops a highly efficient administrative mechanism to fulfill its four major duties, namely reviews of industry personnel qualifications, site equipment inspections, member check-ups, as well as education and training for futures workers. It will actively coordinate the industry's unity and cooperation, promoting communication and interaction between the industry and the competent authorities, and under circumstances of sincere and positive, immaculate policies, lay a more solid foundation for the futures industry.

#### B. Goals

The Association was established to protect the investing public, develop the national economy, coordinate intra-industry relations, and promote common benefits of the society.

#### C. Objectives

- To promote the full functioning of the futures market, working in step with the national economic development
- To make survey, compile statistics, and conduct R&D projects about the operations of member companies
- To make research and suggestions about government's policies and propose revisions to futures-related regulations
- To supervise self-discipline practices of member companies as well as coordinate among members for business promotion and improvement
- To arbitrate disputes among members
- To arrange career training courses and lectures for employees of member companies
- To supervise advertisements, exhibitions, and other promotional activities of member companies
- To handle registrations, conduct surveys, as well as keep records of members as well as representatives and employees of member companies
- To revise or renew licenses of member companies and handle related issues
- To organize or participate social welfare activities
- To protect legitimate rights and interest of member companies
- To take disciplinary actions against wrongful or illegal behaviors of member companies
- To offer the services on request of government agencies or non-profit organizations
- To take part in social activities
- To uphold fair and efficient market order and protect the rights of clients of member companies and other futures traders
- To prevent manipulation, hedging, cheating, fraud, concealment, or other wrongful activities which would mislead futures traders, clients, or other persons associated with futures trading
- To offer other related services on member company's requests in accordance with the government's policies and regulations








# 一、組織系統圖

# 二、組織與執掌

- (一)、會員大會:會員公司可依照經營業務之類別,分別指派會員代表,但每一會員公司最多可指派7位代表,會員代表共計296位。
  - ■成員:由會員代表組成。至107年12月31日止,本公會會員公司計有164家:

    - 2. 兼營期貨商15家
    - 3. 期貨交易輔助人48家

    - 8. 期貨經理業務7家
    - 9. 期貨信託業務10家
  - ■執掌:為本公會最高決策機關。

#### (二)、理事會

- ■成員:33位理事,由會員代表互選之。另設置常務理事11人,由理事互選之。
- ■執掌:理事會為常設機構,亦是本公會決策最高執行單位。並由理事就常務理 事中選舉一人為理事長,對外代表本公會。

# B. Structure and Responsibilities

- General Assembly: member companies, based on their business categories, assign up to 7 representatives each to take part in the General Assembly. In 2018, a total of 296 member representatives were registered with the Association.
  - Member companies: the Association was composed of 164 member companies at the end of 2018:
    - 1. Specialized futures brokerage companies: 14
    - 2. Concurrent futures brokerage companies: 15
    - 3. Futures introducing brokers (IB): 48
    - 4. Foreign re-engaging brokers: 2
    - 5. Proprietary futures commission merchants: 33
    - 6. Leverage Transaction Merchant: 3
    - 7. Futures advisory enterprises: 32
    - 8. Managed futures enterprises: 7
    - 9. Futures trust enterprises: 10
  - Authority: the General Assembly is the supreme policy-making body of the Association.

#### Responsibilities:

- 1. To elect or recall board members or supervisors
- 2. To make and revise CNFA Charter
- 3. To approve annual working plans, budget, auditing reports, and R&D projects
- 4. To review proposals approved at the meetings of board members, supervisors, or General Assembly
- To take disciplinary actions against misbehaved member companies or member representatives
- 6. To trade properties of the Association
- 7. To approve settlement report and appointment of settlement persons as well as handle other settlement-related issues
- 8. To approve dismissing of any board member or supervisor
- 9. To approve member registration fee, annual membership fee, business promotion fee, and donations of member companies
- 10. To approve other issues associated with member's rights or obligations

#### 2. Board of Directors

- Board members: the 33 board members were elected by member representatives during the General Assembly, and 11 executive board members (or executive directors) were elected from board members.
- Authority: the Board of Directors is the Association's highest permanent executive body where members elect a chairman to act on behalf of the Association.

- 2. 監察理事會執行會員大會之決議案。
- 3. 監察理事會會務執行情形。
- 4. 審核理事會各種會計報告書類。
- 5. 稽核理事會之經費收支狀況。

- 7. 議決常務監事及監事之自行辭任。
- 8. 其他依職責應辦之事項。

# Responsibilities:

- 1. To convene the General Assembly and execute its decisions
- 2. To elect or recall chairman or executive directors
- 3. To approve resignation of chairman or board members
- 4. To approve registration, withdrawal, or nullification of membership or member representative
- 5. To make annual working plans, budget, auditing report, and R&D projects
- To approve appointment or dismissing the Association's administrative staff workers, advisors, or research staff workers
- To approve the Association's new regulations or revisions to the CNFA Charter or regulations
- 8. To deal with the projects approved at meetings of supervisors
- 9. To hold a meeting to discuss the proposals originally tendered for discussion at the General Assembly which fails to be held for certain reasons. Decisions made during the meeting will be reported to next General Assembly for its approval.
- 10. To take disciplinary actions against the members who fail to pay membership fee
- 11. To handle issues in accordance with laws, CNFA Charter, or related regulations
- 12. To handle other related issues

#### 3. Supervisors

- Supervisors: the 11 supervisors were elected by member representatives during the General Assembly, and they accordingly elected 3 executive supervisors among whom one was selected as convener.
- Authority: it's the highest supervising body of the Association.

#### Responsibilities:

- 1. To elect or recall executive supervisors
- 2. To supervise the Board of Directors' execution of the projects approved by the General Assembly
- 3. To supervise the Board of Directors' execution of the Association's working plans
- 4. To review the accounting reports which have been approved by the Board of Directors
- 5. To review the financial reports which have been approved by the Board of Directors
- 6. To make annual supervisory report to the General Assembly
- 7. To approve resignation tendered by any executive supervisor or supervisor
- 8. To handle other related issues



Administrative staff: the Association's administration is divided into four sections of Business Development Section I, Business Development Section II, Education & Training Section, and Administrative Management Section, all under the supervision of secretary general and deputy secretary general. Duties of each section are listed below:
  - Business Development Section I:

To handle the business of futures companies, futures (securities) introducing brokers, leveraged trading, and cross-straits issues:

- (1) To arrange meetings of the Futures Brokerage Committee, Proprietary Futures Commission Merchant Committee, Cross-straits Affair Committee, and Discipline Committee
- (2) To handle interactions among regulatory agency, peripheral institutions, and member companies
- (3) To gather information about market trend and industrial development
- (4) To review futures-related laws and, when necessary, propose suggestion for improvement
- (5) To provide legal consulting services to member companies
- (6) To propose or make revisions to self-discipline rules
- (7) To make research on the feasibility of developing new futures-related business in Taiwan and analyze its market potential
- (8) To make research on futures-related topics
- (9) To arrange out-sourcing research projects

# 一、關於期貨交易法令協助推行

A. Implementation of futures-related regulations

增修定範本、規則、申報書表 Formulating contract templates, guidelines, and report formats

修定事項 Amendments to futures-related laws and regulations

1. 修正「分散式阻斷服務防禦與應變作業程序(範本)」,建議期貨業者應要求ISP業者於遭受大量攻擊時提供此告知機制。

Revising the "Distributed Denial of Service (DDoS) Prevention and Reaction Procedures (Reference Sample)," suggesting that futures companies should require ISP operators to trigger this notification mechanism in case of large-scale attack.

2. 將「期貨商行動應用程式檢測」納入「雲端運算、社群媒體、行動裝置資訊安全自律規範」。

Applying the "Self-discipline Rules on Cloud-computing, Social Media, and Mobile Device Information Security" to the "Futures Company's App Inspection."

3. 修正本公會「雲端運算、社群媒體、行動裝置資訊安全自律規範」有關「物聯網設備安全控管」及「防堵釣魚網站之處理規範」等,並更名為「新興科技資訊安全自律規範」。

Revising the CNFA's "Self-discipline Rules on Cloud-computing, Social Media, and Mobile Device Information Security" (revised sections include the "Security Control for IoT Equipment" and the "Regulations on Blocking Phishing Websites") and renaming it as the "Self-discipline Rules on Emerging Technologies."

4. 訂定「期貨業防制洗錢及打擊資恐相關規定問答集」。

Formulating the "Anti-Money Laundering and Counter Terrorism Financing Q&A for Futures enterprises".

5. 為協助期貨業者辦理其機構風險評估,訂定「期貨業洗錢及資助恐怖主義風險評估報告參考實務守則」。

Formulating the "Reference Guidelines for AML/CTF Risk Report of Futures enterprises."

6. 訂定「期貨商及期貨交易輔助人辦理防制洗錢及打擊資恐相關作業參考範本」,有關期貨商對所屬期貨交易輔助人辦理防制洗錢及打擊資恐(AML/CFT)作業表單應注意實質覆核之相關規範。

Formulating the "Guidelines for AML/CTF Practices by Futures Brokerage Companies and Futures Introducing Brokers (Reference Sample) and Related Issues" (regarding the rules which require substantial confirmation of the futures companies on the AML/CFT Practice Report made by their Futures IB.

7. 配合「洗錢防制法」、「資恐防制法」之訂定、主管機關修正洗錢防制相關法令規範、及本公會「期貨信託事業暨期貨經理事業防制洗錢及打擊資恐注意事項範本」等,修正本公會「期貨經理事業內部控制制度標準規範」及內部稽核實施細則、「期貨信託事業內部控制制度標準規範」及內部稽核實施細則。

In order to cope with the government-published "Anti-Money Laundering Act," the "Countering Terrorist-financing Act," and related regulations, as well as revisions to the CNFA's Guidelines for AML/CTF Practices by Futures Trust and Managed Futures Enterprises (Reference Sample)," the CNFA revised its "Standards for Internal Control System of Managed Futures Enterprises" and the "Standards for Internal Control System of Futures Trust Enterprises" as well as related enforcement rules.

# **Association Affairs**

8. 為落實節能減碳及推動期貨經理事業無紙化作業,修正「期貨經理事業經營全權委託期貨交易業務操作辦法」、「期貨經理事業內部控制制度」及「期貨經理事業內部稽核實施細則」,有關「交易決定人員應於『交易前』完成決定書並完成覆核作業」。

In order to cope with the government's "energy-saving and carbon-reducing" policy and to promote paperless operation of managed futures enterprises, the CNFA revised the "Guidelines for Managed Futures Enterprises in Handling Discretionary Account Management Business," the "Internal Control Mechanism of Managed Futures Enterprises," and the "Enforcement Rules for Internal Control Mechanism of Managed Futures Enterprises," requiring that "transaction decision makers should, 'prior to the transaction,' be sure to complete the transaction form and go through all the confirmation procedures."

9. 參考證券全權委託作業,於期貨經理事業運用期貨全權委託資金複委託證券商買賣國外有價證券時,排除投資買賣帳戶應以客戶名義為之(即得以受託之證券商名義簽訂開戶或買賣契約),修正「期貨經理事業經營全權委託期貨交易業務操作辦法」、「期貨交易全權委任契約範本」及「保管機構委任契約範本」相關內容。

Referring to the discretionary account management model for securities transaction and revising the "Guidelines for Managed Futures Enterprises in Handling Discretionary Account Management Business," the "Contract of Discretionary Account for Futures Trading (Template)" and the "Contract of Authorizing Custodian Banking Institution (Reference Sample)," scrapping the requirement that the Managed Futures Enterprises should use their client's title for opening the discretionary account which may re-consign securities firms to trade foreign securities (i.e., to allow the authorized Managed Futures Enterprises to use their own titles to open such accounts or sign on related transaction contracts).

10.配合櫃買中心開放指數股票型期貨信託基金得申請櫃檯買賣,修正本公會「期貨信託契約範本(一般型)」及「期貨信託基金之募集、發行、銷售及申購買回作業程序」、「期貨信託事業受益憑證事務處理規則」。

Revising the CNFA's "Template of Futures Trust Contract (General Type)," the "Procedures for Futures Trust Fund Raising, Issuance, Sales, Subscription, and Redemption," and the "Guidelines for Managed Futures Enterprises in Handling Beneficiary Issues," in cope with the Taipei Exchange's policy to allow the stock index futures trust fund to apply for making OTC translations.

11. 修正「期貨信託事業受益憑證事務處理規則」、「期貨信託基金電子交易作業準則」及「期貨信託 基金電子交易約定書範本」增訂客戶透過電子化方式簽署開戶文件,期貨信託事業或基金銷售機構 進行客戶身分確認之程序。

Revising the "Guidelines for Managed Futures Enterprises in Handling Beneficiary Issues," the "Guidelines for Managed Futures Enterprises in Handling Electronic Transactions," and the "Electronic Transaction Contract of Futures Trust Fund (Template)," defining the procedures for Futures Trust Enterprises or fund sales agents to confirm client's identification while dealing with electronic translation applications.



# 研議、建議事項 Proposals

# 擴大業務範圍事項 Business expansion issues

- 1. 研議「期貨商開戶徵信作業管理自律規則」,對期貨交易人加收保證金之相關規定。 Proposing to revise the "Self-discipline Rules on Futures Companies in Checking Identification of New Account Applicant," regarding the regulations on raising the deposit of futures traders.
- 2. 配合政府發展高齡化金融商品與服務,本公會與期交所共同研議「期貨商開戶徵信作業管理自律規則」有關 七十歲以上交易人之開戶、徵信及交易等相關規定。
  - In cope with the government's policy for developing financial services and products for the elderly people, the CNFA and the TAIFEX are jointly proposing to revise the "Self-discipline Rules on Futures Companies in Checking Identification of New Account Applicant," regarding account-opening, credibility checking, transactions, and related requirements on the people aged 70 or above.
- 3. 建議臺灣期貨交易所於交易人同意前提下,對交易人以「自動」委託方式之期貨商品,得經期貨商檢核保證金 後,以新倉執行委託送交期交所進行撮合。
  - To suggest that the TAIFEX should, with the consent of futures traders, be able to do transaction-matching for the new account position of the managed futures products which have been entrusted by the traders for "automatic" trading through the account where the deposit has been approved by the Managed Futures Enterprise.
- 4. 建請主管機關放寬得申請採行整戶風險保證金計收方式(SPAN)交易人之資格。 To suggest that the regulatory agency should relax the qualification requirements of the SPAN traders.
- 5. 建議臺灣期貨交易所開放期貨商之客戶如係透過保管機構辦理有關期貨交易之結算交割及資料申報等事宜者, 期貨商得以加密電子郵件寄送買賣報告書或對帳單。
  - To suggest that the TAIFEX should allow futures companies to send the transaction reports or settlement reports through SSL-certified emails to the clients who have gone through the procedures for allowing their custodian institutions to handle trading settlement and reporting issues.
- 6. 為持續瞭解期貨業落實防制洗錢及打擊資恐AML/CFT制度執行情形,辦理「期貨業AML/CFT遵循成效評估問 卷」,並將分析結果並提供主管機關據以採取適當監理措施。
  - In order to grasp the AML/CFT practices by futures enterprises, the CNFA will make "Analysis of the Anti-Money Laundering/Counter Terrorism Financing Compliance and Performance Questionnaire for Futures Enterprises" and make analysis for reference of the regulatory agency.
- 7. 自108年起銀行業週末補行上班日,期貨市場不交易不結算交割,建議臺灣期貨交易所不辦理出金作業。 To suggest that the TAIFEX should not process cash flow issues for futures trading on the working Saturday when, since the beginning of 2019, the banks won't handle settlement procedures for futures trading.
- 8. 建請主管機關同意給予實施「期貨商法令遵循之評估內容與程序標準規範」之緩衝期間6個月。 To suggest that the regulatory agency should give a buffer period of six months for the "Guidelines for Futures Companies in Compliance Assessment Items and Procedures."
- 9. 建議臺灣期貨交易所新增「停損限價」及「一定範圍停損市價」委託種類。 To suggest that the TAIFEX should add the two categories of "trading at loss-limit price" and "trading at loss-limit price range" to the trader-authorized futures trading.
- 10. 建議臺灣期貨交易所調整向期貨商收取「電腦連線處理費」之費率。 To suggest that the TAIFEX should adjust the rate of the "computer-network handling fee" charged to the futures companies.
- 11. 建議臺灣期貨交易所同意放寬期貨商執行代為沖銷作業時,當該交易人未平倉部位中之股票期貨,於當日盤中 已出現漲(跌)停成交價時,可排除適用「期貨商開戶徵信作業管理自律規則」第八條「全程禁止使用漲跌停 ROD委託單」之規定及刪除「附表」表單。
  - To suggest that the TAIFEX should allow the futures companies, while writing off the position at a trading account on behalf of the client at whose trading account the unsettled stock futures have hit the daily high/low price limit during that day's strading hours, to exempt from the requirement of Article 8 "Futures Companies are prohibited from using ROD Commission Form During All Trading Hours" of the "Self-discipline Rules for Futures Companies during Credibility-checking Procedures for Account Opening" remove its "Appendix Form."
- 12. 為降低結算會員成本負擔,建議臺灣期貨交易所調整結算會員繳存至該公司結算保證金專戶內款項之「帳務管 理費」費率,期交所於108年1月10日函復同意減收帳戶管理費40%(相較前次,再減收15%)
  - In order to help settlement members reduce their operational cost, the CNFA previously had requested the TAIFEX to lower the rate of the "account management fee" for its settlement members' deposit at the special settlement deposit account, and has received the TAIFEX' s reply on January 10, 2019 that it would cut the rate by 40% (following a 15% cut of last time).

- 13. 為避免低流動性商品產生價格偏離致無法即時平倉或連鎖代沖銷之風險及影響期貨商系統之風控洗價效率、增加系統負擔及人力經營成本,建議臺灣期貨交易所定期檢視低流動性商品,並報請主管機關核准終止上市。 Considering that the prices of low-liquidity products may deviate too far for futures traders to offset their accounts or for the futures companies to write off the position at the accounts on behalf on their clients and that would influence the risk-control mechanism of futures companies which would accordingly bear heavier human and overall operational cost, the CNFA thus proposes to suggest that the TAIFEX should examine the low-liquidity products regularly and apply to the regulatory agency for delisting these products.
- 14. 建請主管機關同意開放期貨交易輔助人受託買賣執行業務員,得轉介槓桿保證金契約相關商品或其他經主管機關 核准之商品。
  - To suggest that the regulatory agency should allow the futures IB workers, who are commissioned by clients to make futures trading, could make referrals of margin-trading or related government-approved products to their clients.
- 15. 為利提供委託人全方位最適化之資產管理,建請主管機關函釋華僑及外國人投資有價證券,得以委任方式委託 期貨經理事業,並協助與央行溝通配合開放期經得受託投資有價證券。

It's joined by around 150 participants.

The CNFA invited the executives in charge of risk-control, information management, and related fields from the specialized futures brokerage companies and futures brokerage affiliates of financial institutions to discuss the issues such as trader classification, extra charge for trading on low-liquidity products, targets of SPAN, optimized alternative to deposit collection, making write-off on behalf of clients and pressure test, as well as other adjustment issues regarding how to strengthen services for futures traders.

In order to address the responsibilities and professional skills of the AML/CTF frontline workers so as to help them strengthen their practices at work, the CNFA held the AML Seminar in northern, central, and southern Taiwan, respectively, participated by a total of 307 attendees including supervisors, sales representatives, compliance department workers, internal auditing workers, and so on.

It gathered over 300 topranking executives and heavyweight clients of the financial industry. Through reports of the mass media, this event substantially raised the public's awareness on the AML/CTF issues.

It gathered a total of 126 attendees and drew active feedback.

It's participated by 380 attendees.

The lectures were arranged to help students understand the futures market as well as jobs of futures workers and related job requirements, and that would prompt them to take earlier steps to plan for their careers in the future.

The CNFA was responsible for screening the trainees for this Course which, since inception, has seen 369 trainees find competent jobs after completing the training course.





#### 2.107年度證券期貨盃高爾夫球聯誼賽 (5/1)


## D. Inspection of advertisement and promotional materials of member companies

Advertisement and Business Promotion Projects of CNFA Members in 2018








#### 近10年會員家數統計圖

Statistics of CNFA Member Companies in 2018, by Business Category



Geographical Location of Business Sites of CNFA Member Companies in 2018








#### 107年度場地勘察區域分布統計圖

Geographical Areas of Inspected Business Sites in 2018




Statistics of Business Site Inspection Projects in 2018


